Budget for 2013 Fiscal Year

The Manor operates on a fiscal year from July 1 through June 30. The first reading of the 2013 budget ordinance was completed at the April 27 meeting. The second reading occurred at the May 23 meeting at which time the 2013 budget was enacted via Ordinance Series 2013, Number 2, a copy of which is attached.

The Manor City Commission

Forestry Board Update

Members of the Forestry Board recently completed a neighborhood walk to prioritize trimming and planting needs. Green Haven performed trimming and maintenance throughout the Manor in recent weeks, including the removal of several dying or damaged trees. Several new trees will be planted this Fall after the temperatures cool.

Property Taxes

Ordinance series 2013-1 (a copy is attached) was enacted in April, establishing the tax rate at 37.1 cents per \$100 of valuation as established by the Jefferson County PVA.

The tax bills for 2013 City of Strathmoor Manor property tax were mailed out in late May and taxes were due by August 1 in order to avoid a penalty. It is the responsibility of the homeowner to insure taxes are paid. If you no longer carry a mortgage on your property, you must directly pay your property taxes. If you have a mortgage, please contact your mortgage company to confirm taxes were remitted on your behalf!

Parking Reminders:

- Please continue to obey the parking signs throughout the Manor and refrain from parking on grass or across sidewalks
- Remind your guests and contractors to obey the Manor parking signs and restrictions as well

Revision to Non-Solicitation Ordinance

In an effort to deter door-to-door solicitation, the Manor has a non-solicitation ordinance requiring solicitors to contact the Strathmoor Police Department to complete an application and purchase a permit. The ordinance was recently expanded via Ordinance Series 2013-3 (copy attaced) to include telecommunications companies.
