Some Reminders on Mulching

Mulching is one of the best things you can do to promote tree health. Proper mulching can:

- Reduce soil moisture loss
- Control weed germination and growth
- Protect roots from extreme summer and winter temperatures
- Improve soil biology, aeration, structure, drainage, and fertility
- Inhibit certain plant diseases
- Reduce the likelihood of damage from weed trimmers or lawn mowers

Proper Mulching Technique

Organic mulch (wood chips, pine needles, hardwood and softwood bark, etc.) is preferred over inorganic mulch (stone, lava rock, pulverized rubber, etc.).

- Apply a 2- to 4-inch layer of mulch (less if poorly drained).
- Spread mulch out to the edge of a tree's crown or beyond.
- If mulch is already present, check depth. Break up any matted layers and refresh the appearance with a rake.
- If mulch is piled against the stems or tree trunks, pull it back several inches/centimeters so that the base of the trunk is exposed.

The Hazards of Improper Mulching

As beneficial as mulch is, too much can be harmful. It is important to avoid "mulch volcanoes" -- excessive mulch applied around the base of a tree which can lead to the development of insects and disease as well as other problems.

CITY OF STRATHMOOR MANOR

Ordinance Series 2018, Number 1

AN ORDINANCE amending the Strathmoor Manor Code of Ordinances to renew a non-exclusive franchise to provide cable television and other telecommunications services within the City limits and declaring the existence of an emergency.

WHEREAS pursuant to Ordinance Series 1978, Number 1 a non-exclusive franchise was awarded to CPI, Incorporated to provide cable television and other telecommunications services within the City limits; and,

WHEREAS said franchise was renewed pursuant to Ordinance Series 1988, Number 6 in the name of Storer Communications, successor in interest to CPI, Incorporated; and,

WHEREAS said renewed franchise expired on March 25th, 2005 and requires renewal; and,

WHEREAS Insight Kentucky Partners II, L.P. doing business as Charter Communications is the current successor in interest to CPI, Incorporated.

NOW THEREFORE **BE IT ORDAINED BY THE CITY OF STRATHMOOR MANOR** that:

- (a) An emergency exists in that the franchise agreement has expired and requires renewal.
- (b) Strathmoor Manor Code of Ordinances Section 6.101 is hereby amended to read as follows:

The non-exclusive franchise to construct, operate and maintain a community antenna television (CATV) system within the City of Strathmoor Manor pursuant to the authority and provisions of Ordinance Series 1978-10 and *currently* held by *Insight Kentucky Partners II, L.P. doing business as Charter Communications Storer Communications of Jefferson County, Inc. is hereby renewed, commencing with the effective date of this ordinance and <i>continuing for a period of ten (10) years* terminating on March 25, 2005.

- (c). The Mayor is authorized to execute the Franchise Agreement on behalf of the City.
- (d) This ordinance shall take effect immediately upon passage and publication.

Ordinance Series 2018, Number 2

AN ORDINANCE relating to the ad valorem tax rate on real property.

BE IT ORDAINED BY THE CITY OF STRATHMOOR MANOR that:

Section 1. Section 2.605(a) of the Strathmoor Manor Code of Ordinances is amended to read as follows:

The tax rate on non-exempt real property within the corporate limits of the City of Strathmoor Manor shall be 32.00 cents per \$100.00 valuation.

Section 3. Section 2.605(b) of the Strathmoor Manor Code of Ordinances is amended to read as follows:

This ordinance shall take effect with the issuance of the $\frac{2016}{2018}$ 2018 Property Tax Bills of the City based on valuations of real property as of January 1st, $\frac{2017}{2018}$ by the Jefferson County Property Valuation Administrator.
